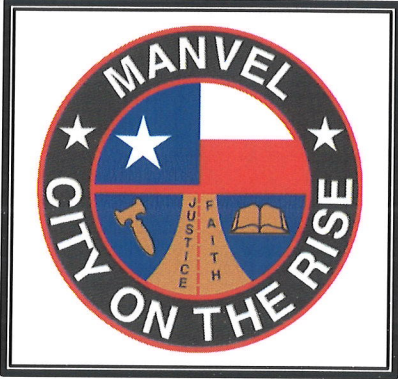

**Public Hearing**

**A. Public hearing to hear comments for or against proposed Project 2025-02. Grease Monkey - site improvements for auto shop commercial business.**

The Manvel Economic Development Corporation (the “Corporation”) will consider, as a project of the Corporation the expenditure of funds in the estimated amount of up to \$20,000 to be required or suitable for one or more of the following categories provided by state law:

(1) infrastructure necessary to promote or develop new or expanded business enterprises, limited to: (a) streets and roads, rail spurs, water and sewer utilities, electric utilities, or gas utilities, drainage, site improvements, and related improvements and (b) telecommunications and Internet improvements [Tex. Local Gov’t Code §501.103];

(2) land, buildings, equipment, facilities, and improvements found by the board of directors to promote or develop new or expanded business enterprises that create or retain primary jobs, including public safety facilities, streets and roads, drainage and related improvements, demolition of existing structures, general municipally owned improvements, and any improvements or facilities related to a project described herein [Tex. Local Gov’t Code §505.155];

(3) equipment, facilities, and improvements found by the Board of Directors to promote new or expanded business development [Tex. Local Gov’t Code §505.158].

The project site is located at 20815 Highway 6, Manvel, TX. Said project is to include the expenditure of up to \$20,000 to be reimbursed to applicant **Grease Monkey Manvel** for site improvements for the auto shop facility in a commercially targeted area, which will further economic development, create commercial investment, and create and/or retain jobs in the City of Manvel. (“Project 2025-02”).


